## TECHNICAL STANDARDS

Type MC is manufactured per UL Standard 1569 NEC Article #334.

## PAYMENT TERMS

Terms are 2% 10<sup>th</sup> prox. month, net end of prox. month. Cut off dates have been moved from the 25th to the 30th. Any invoices with dates for days 1- 30 of the month are due with discount by the 10th of the month following the invoice month, and are due net by the last day of the month following the invoice month.

(Example: Invoice date of 03/30, due with discount on 04/10, and due net by 04/30.)

Any invoices dated the 31<sup>st</sup> of a month are due with discount by the 10th of the second month following the invoice month, and are due net by the last day of the second month following the invoice month.

(Example: Invoice date of 03/31, due with discount on 05/10, and due net by 05/31.)

## MINIMUM ORDER
